This letter is in follow up to the March 29, 2023 briefing myself and House Permanent Select Committee on Intelligence (HPSCI) Chairman Turner received regarding the Federal Bureau of Investigation (FBI) Inspection Division's (INSD) Internal Review related to the 2018 Schoharie limousine crash in New York State. As you know, this was the United States' most deadly transportation disaster in decades and was wholly preventable.


Despite the March 29 briefing, additional work is needed for full transparency regarding the FBI's apparent lack of adherence to their confidential human source program's standard operating procedures. Most importantly, the grieving families impacted by this tragic event deserve to be briefed by the FBI, so they can have full and much-needed closure.

Due to the confidential nature of the INSD review that was provided to HPSCI on March 29, 2023, I will concurrently transmit additional questions for the FBI to be prepared to address in the next briefing on this subject. I expect full accountability and cooperation on this issue. Moreover, as I indicated on March 29, the upcoming brief on this matter shall be provided by FBI agents with firsthand knowledge of the case files and material.

I again remind you that it is Congress, not the FBI, that determines what constitutes full transparency and the fulfillment of Congressionally-mandated oversight role on this matter.

I appreciate your full compliance and look forward to receiving the requested information and documentation promptly.
