I am requesting funding for the Town of Inlet Municipal Building Modernization Project in Fiscal Year 2027. The entity to receive funding for this project is the Town of Inlet, located at 160 Route 28, Inlet, New York 13360.

The funding would be used to modernize the municipal building housing Town offices and the police station through window replacement, installation of energy-efficient heating and cooling systems, roof repairs, interior infrastructure upgrades, safety improvements for law enforcement operations, and expansion of office space to support continued delivery of municipal services.

The project is an appropriate use of taxpayer funds because it preserves a critical public facility supporting municipal governance, law enforcement operations, and emergency services in a rural Adirondack community while improving safety, accessibility, and long-term energy efficiency.

The project has a federal nexus because the funding provided is for purposes authorized under 7 U.S.C. §1926(a) through the USDA Rural Development Community Facilities Program, which supports essential public service facilities serving rural populations.
