
Dear Chairman Cole and Ranking Member DeLauro,

I am requesting funding for Clinton County, NY, Clinton County Sheriff Maritime Patrol Vessel in fiscal year 2025. The entity to receive funding for this project is Clinton County Sheriff's Office, located at 25 McCarthy Drive Plattsburgh, NY, 12901. The funding will enable the Clinton County Sheriff's Office to purchase a safe boat type marine patrol vessel to allow for safe operations in all weather conditions, day and night, on the international waterway of Lake Champlain connecting Canada with New York state and Vermont.
