# A BILL

To improve the intelligence received by the Secretary of State to identify, prevent, and respond to atrocities.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Geospatial Support  
5 for Atrocity Accountability Act”.

6 **SEC. 2. PROVISION OF INTELLIGENCE TO IDENTIFY, PRE-**  
7 **VENT, AND RESPOND TO ATROCITIES.**

8 (a) IN GENERAL.—The Secretary of State, acting  
9 through the Assistant Secretary for the Bureau of Conflict

1 and Stabilization Operations, shall ensure that the De-  
2 partment of State receives the following information of the  
3 United States Government:

4 (1) Intelligence to identify, prevent, and re-  
5 spond to atrocities pursuant to the Elie Wiesel  
6 Genocide and Atrocities Prevention Act of 2018  
7 (Public Law 115–441; 132 Stat. 5586).

8 (2) Evidence and information collected, ana-  
9 lyzed, or preserved relating to war crimes, other  
10 atrocities, forced disappearances, and atrocity crime  
11 scenes.

12 (b) DEPARTMENT OF STATE ATROCITY WARNING  
13 TASK FORCE.—The Secretary of State shall ensure that  
14 intelligence, evidence, and information received pursuant  
15 to subsection (a) is provided to the Department of State  
16 Atrocity Warning Task Force. The Task Force shall pro-  
17 vide unclassified commercial geospatial imagery and anal-  
18 ysis of such imagery received pursuant to subsection (a)  
19 to—

20 (1) appropriate domestic, foreign, and inter-  
21 national courts and tribunals prosecuting persons re-  
22 sponsible for crimes for which such imagery may  
23 provide evidence (including genocide, crimes against  
24 humanity, and war crimes, including with respect to

1 missing persons and suspected atrocity crime  
2 scenes);

3 (2) the International Commission on Missing  
4 Persons and relevant civil society organizations (in  
5 addition to providing such organizations with other  
6 evidence archived by the Task Force); and

7 (3) the public to notify persons of potential  
8 atrocities and warn persons who are believed to be  
9 preparing to commit atrocities.

10 (c) DEFINITIONS.—In this section:

11 (1) ATROCITIES.—The term “atrocities” has  
12 the meaning given that term in section 6 of the Elie  
13 Wiesel Genocide and Atrocities Prevention Act of  
14 2018 (Public Law 115–441; 132 Stat. 5586).

15 (2) ATROCITY CRIME SCENE.—The term  
16 “atrocity crime scene” means one or more locations  
17 that are relevant to the investigation of an atrocity,  
18 including buildings or locations (including bodies of  
19 water) where physical evidence may be collected re-  
20 lating to the perpetrators, victims, and events of the  
21 atrocity, such as mass graves and other sites con-  
22 taining deceased individuals.
